Carmine Bianchi is a Professor of Public Management in the Department of Political Sciences, University of Palermo (Italy), where is also the scientific coordinator of the CED4 System Dynamics Group. At Palermo, he is also the director of the Doctoral program in "Model Based Public Planning, Policy Design, and Management", and of the Master in Public Management. Professor Bianchi has research and consulting experience with public and private sector organizations in designing policies and outlining consistent programs to link policy design and implementation. In the last decade, Prof. Bianchi's scientific interests have been focused on the design of outcome-based dynamic performance management systems aimed at fostering collaborative governance and enhancing quality of life in local areas. Professor Bianchi is a member of the Editorial Board of leading international Journals, such as the International Journal of Public Administration, Public Administration Review, Public Management Review, and Public & Performance Management Review. He is also the Editor of the Book Series on "System Dynamics for Performance Management & Governance", by Springer

- ¹ Jiannan Wu is Distinguished Professor and Executive Vice Director of China Institute of Urban Governance and Head of Division for Liberal Arts and Social Science, Shanghai Jiao Tong University. After obtaining his Ph.D. at School of Management at Xi'an Jiaotong University (XJTU) in 1999, he was appointed as a postdoctoral research associate at the Center for Technology and Information Policy (CTIP) of Maxwell School of Citizenship and Public Affairs at Syracuse University. He also worked as a Fellow in the Ash Center of Harvard Kennedy School in 2012.
- Dr. Wu has worked on, performance management, Reform & innovation, and Urban governance for years. He has published extensively in Chinese leading Journals and some English work has appeared in Public Administration, International Public Management Journal, Journal of Cleaner Production, International Review of Administrative Sciences, Review of Public Personnel Administration, Journal of Public Administration Research and Theory, Administration & Society, and Public Management Review. Dr. Wu has served on the Editorial Board of the International Public Management Journal and several Chinese journals.
- Dr. Wu has served as Vice President of the National Government Performance Management Research Association of China since 2006, Executive member of the Chinese Public Administration Society and other Chinese academic societies. He has served as General Secretary of the Asian Association of Public Administration since 2018. He has been a peer reviewer for Public Administration J-PART, IPMJ, JCPA, PPMR, PMR, ROPPA, Cities, and so on.
- ^a Jeremy L. Hall is Professor of Public Administration and Director of the Ph.D. Program in Public Affairs at the University of Central Florida. An international expert on public management, performance and accountability systems, and evidence-based practice and policy, Dr. Hall is Editor-In-Chief of Public Administration Review and a National Academy of Public Administration fellow. An active ASPA member, Hall chaired the program committee for the 2016 ASPA annual conference in Seattle, Washington. He serves on the editorial boards of Public Performance & Management Review, State and Local Government Review, the Journal of Public Affairs Education, the Commonwealth Review of Political Science, and previously, The Journal of Public Administration Research and Theory, and Public Administration Review. His research appears in key academic journals including: The Journal of Public Administration Research and Theory, Public Administration Review, American Review of Public Administration, Economic Development Quarterly, Public Performance & Management Review, Publius: The Journal of Federalism, Policy Studies Journal, the Journal of Public Affairs Education and others. Hall is President-elect of the Southeastern Conference of Public Administration (SECoPA) where he has served four nonconsecutive terms on the board of directors. He joined Ted Poister and Maria Aristigueta as a coauthor of the revised edition of the seminal text on performance management: Managing and Measuring Performance in Public and Nonprofit Organizations: An Integrated Approach, published by Jossey-Bass/Wiley in 2014. His 2010 book (Grant Management: Funding for Public and Nonprofit Programs) is the first to examine grant writing and grant management from a Public Administration perspective.
- B Guy Peters is Maurice Falk Professor of American Government at the University of Pittsburgh and Professor of Comparative Governance at Zeppelin University (Germany). He is also an adjunct professor at the City University of Hong Kong. He has a PhD from Michigan State University and has three honorary doctorates from European universities. He is now co-editor of the Handbook of Public Administration in Latin America, and of several book series for Macmillan.
